

# STELLA ARTOIS SUNDAY ROAST COMPETITION RULES

## 20 SEPTEMBER 2023 - 22 SEPTEMBER 2023

#### 1. Introduction

- 1.1. This promotional competition ("Competition") is run by The South African Breweries (Pty) Ltd ("Promoter") and is open to all persons of 18 years or older and resident in South Africa, except for (a) the directors, members, partners, agents, consultants or employees of the Promoter and their immediate families, (b) the directors, members, partners, agents, consultants or employees of any suppliers of any goods or services to the Promoter in respect of this Competition, (c) directors, members, partners, agents, consultants or employees of the Promoter's advertising and promotion agencies or associated companies, and (d) participating outlet owners and staff.
- 1.2. The rules set out in this document constitute the rules which will govern the Competition ("Competition Rules").
- 1.3. Participation in the Competition by an entrant ("Participants") constitutes acceptance of these Competition Rules by that Participant.

## 2. Competition Period

This Competition will run from 20 September 2023 until 22 September 2023, both dates inclusive, or until the Promoter provides a public notice that the Competition has ended, whichever is earlier ("Competition Period"). Entries will only be accepted during the Competition Period.

# 3. Competition Entry Process

- 3.1. This Competition will take place on Twitter, Instagram and Facebook. In order to enter the Competition, a Participant must:
  - 3.1.1. retweet the relevant post related to the Competition on Twitter (available at @StellaArtoisZA), tag a friend who the Participant would like to bring with to the Event (defined below) and include the hashtag #StellaSundayRoast; or
  - 3.1.2. reshare the relevant post related to the Competition on Instagram (available at @stellaartoisafrica) and tag a friend who the Participant would like to bring to the Event and include the hashtag #StellaSundayRoast; or



- 3.1.3. reshare the relevant post related to the Competition on Facebook (available at @StellaArtoisAfrica) and tag a friend who the Participant would like to bring to the Event and include the hashtag #StellaSundayRoast.
- 3.2. Entry is only valid through this medium and in this manner. A Participant may only enter the Competition once.
- 3.3. Participants are liable for their own data and voice charges in respect of the Competition participation as well as any verification process, if applicable.

## 4. Description of Prize

- 4.1. The prize for this Competition is 1 of 5 double tickets for the winner and their guest (a "Guest") to attend the Sunday Roast event sponsored by Stella Artois (the "Event") held at the Fat Olive, Pelindaba Road, Lanseria, 1748, Johannesburg, South Africa on 24 September 2023 between 13:00 PM and 22:00 PM (the "Prize"). The Prize includes a set menu of food and alcoholic beverages (determined solely by the Promoter or its nominated agent at its discretion) to be enjoyed responsibly, for winners and their Guests who attend the Event between 13:00 PM and 15:30 PM ("Designated Time") on the day of the Event. The Prize does not include any food and beverages before or after the Designated Time. Before and after the Designated Time, the winners and their Guests are responsible for purchasing their own food and beverages (to be enjoyed responsibly) at the Event. In order to receive and attend the Prize, winners and their Guests will be required to sign an event indemnity form to be provided by the Promoter.
- 4.2. There are a total of 5 Prizes available to be won during Competition Period and each Prize has a value of approximately R800.00.
- 4.3. The winner is responsible for the cost of travel to the local venue or Event.
- 4.4. No person may win more than one Prize in this Competition.
- 4.5. The winner may not transfer a Prize, in whole or in part, to any other person or exchange a Prize for an alternate prize or for its cash value. A winner may not substitute him/herself with any other person.
- 4.6. The Promoter will send the Prizes to the winner electronically.

### 5. Winner Selection and Notification

- 5.1. The winner will be selected by a random draw process. The draw will take place on or before 22 September 2023 and will consist of all valid entries received during the Competition Period.
- 5.2. The winner will be notified by the Promoter via direct message on the social media platform on which the Participant entered the Competition and a subsequent phone call on or before 22 September 2023.



If the Promoter is unable to contact the winner, he/she will be disqualified and a substitute winner may at the discretion of the Promoter be selected, using the same winner selection process.

#### 6. Winner Verification

- 6.1. The winner and their Guest must be over the age of 18 (eighteen) years old and must comply with the Participant eligibility criteria set out in Competition Rule 1.1 and the requirements in these Competition Rules, which may be verified by or on behalf of the Promoter. The Participant and Guests may be asked to provide a copy of his/her identity document/passport/driver's license/proof of residential address/proof of purchase, if applicable, in order to be eligible to receive the Prizes. The Promoter reserves the right to conduct the validation and verification process via automated means and/or any other means that the Promoter may deem necessary, and by participating in the Competition, all Participants and Guests consent to the appropriate validation and verification measures that the Promoter may implement from time to time.
- 6.2. A Prize will only be awarded by the Promoter and the Participant will only be regarded as the winner after the verification process set out in these Competition Rules has been completed to the satisfaction of the Promoter. Failing successful verification of the Participant, a substitute winner may be selected at the discretion of the Promoter.
- 6.3. The Promoter reserves the right to carry out audits in respect of the Participant or Guest to verify his/her eligibility and/or the validity of the Participant's entry. The Promoter may disqualify the Participant if any fraud or cheating or related activity is suspected, including without limitation, through the manipulation of an entry or otherwise falsifying data. Should the Promoter or its agent determine that an entry or Participant is invalid or ineligible, the relevant Participant or Guest shall not be entitled to receive the Prize and will not be compensated in any way.
- 6.4. A Participant will be ineligible to win, and automatically be excluded from winning, a Prize under this Competition if a Participant previously won a prize to the value of R10 000 or more from the Promoter in the preceding 12 months from the start date of this Competition.

## 7. Prize Forfeiture

- 7.1. The winner and their Guest must communicate his/her full details to the Promoter or its agent as requested by the Promoter or its agent. Failure to do so may result in forfeiture of the Prize.
- 7.2. If the winner or their Guest is unable to attend, receive or utilise (as applicable) the Prize then the entire Prize shall be forfeited. There will be no compensation, in any form, including, but not limited



- to monetary compensation and/or rescheduling, to any party, irrespective of the reason/s for the inability of that winner to attend, receive or utilise (as applicable) the Prize.
- 7.3. Time permitting and subject to the Promoter's approval, where the Prize is forfeited a substitute winner may be chosen in the same manner as the original winner was chosen.

#### 8. General

- 8.1. Should the process for entry into the Competition or the Prize/s involve any alcoholic beverage,

  Participants shall ensure that it is enjoyed responsibly.
- 8.2. To the extent that any intellectual property right/s arise as a result of or through the creation and/or submission by a Participant of content, including without limitation any pictures, videos, drawings or other creative works, to enter this Competition, such intellectual property right/s will vest in the Promoter and the Participant hereby waives any associated right/s. To the extent such rights have vested in a Participant, the Participant hereby cedes, assigns and transfers (by way of present and future cession, assignment and transfer) to Promoter such rights and undertakes to do such things, takes such steps and sign such documents as are necessary to give effect to such cession, assignment and transfer. Each Participant indemnifies and holds harmless the Promoter from and against any and all claims, actions, legal proceedings, losses, damages and expenses (including attorney's fees and expenses) arising as a result of or in connection with any actual or alleged infringement of any intellectual property rights of a third party arising from entry in the Competition and/or the Promoter's use of any content, including without limitation any pictures, videos, drawings or other creative works, created pursuant to the Participant's entry in the Competition.
- 8.3. In the event of a dispute, the Promoter's decision is final and binding and no correspondence will be entered into.
- 8.4. The timelines stated by the Promoter or its agent must be adhered to. Failing adherence to any timeline, at any stage, may result in disqualification and forfeiture of the Prize in its entirety with no compensation to any party by the Promoter.
- 8.5. Each Participant and Guest, by participating in the Competition or receiving a Prize, acknowledge, agree and expressly consent to:
  - 8.5.1. the Promoter processing the Participant's and Guest's personal information, including in the form of names, telephone numbers, identity numbers and/or email addresses, during and after the course and scope of the Competition; and



- 8.5.2. the Promoter transferring the winning Participant's and Guest's personal information, including names, telephone numbers, identity numbers and/or email addresses, to the relevant third parties in order to make any required travel, delivery or other arrangements, as may be applicable, during the course and scope of the Competition for utilisation of the Prize,
  - which processing and transfer shall take place in accordance with the provisions of the Protection of Personal Information Act 14 of 2013 ("POPIA") and any other applicable law, and for the purpose of giving effect to the Competition.
- 8.6. With the exception of Competition Rule 8.5 above, the Promoter will not share any personal information with any third party except where such disclosure is necessary to enable the Promoter to provide, deliver or in any other way give effect to these Competition Rules and/or the Prize, where such disclosure is permitted by law and/or where consent to sharing personal information is obtained from the relevant Participant by the Promoter. The Promoter will comply with the relevant data protection legislation, including POPIA.
- 8.7. A Participant or Guest may submit a request at <a href="https://www.sab.co.za/content/data-subject-request-op">https://www.sab.co.za/content/data-subject-request-op</a> of for the Promoter to:
  - 8.7.1. correct or delete personal information about the Participant or Guest in the Promoter's possession or under its control that is inaccurate, irrelevant, excessive, out of date, incomplete, misleading or obtained unlawfully; or
  - 8.7.2. destroy or delete a record of personal information about the Participant or Guest that the Promoter is no longer authorised to retain.
- 8.8. The Promoter may make media announcements containing, or otherwise publish, the names and/or photographs of the winner and their Guest without remuneration being payable to the winner or their Guest, provided that the Promoter will not do so if the winner or their Guest communicates in writing to the Promoter that he/she does not want his or her names or photographs to be contained in media announcements or otherwise published.
- 8.9. Should a Prize not be available despite the Promoter's reasonable endeavours to procure a Prize, the Promoter reserves the right to substitute a Prize with another of equal value as determined in the Promoter's sole discretion and subject to availability. No person will entitled to be compensated in any way in this instance by the Promoter.
- 8.10. The Promoter will not be responsible for any costs, expenses or other liabilities incurred by the winner or their Guest which are not expressly contemplated as part of a Prize.



- 8.11. These Competition Rules may be amended by the Promoter on public notice at any time during the Competition Period or thereafter. These Competition Rules will be interpreted by the Promoter only.
- 8.12. The Promoter reserves the right to alter, amend or cancel this Competition in whole or in part. Any alterations, amendments or cancelations will be interpreted by the Promoter only. In the event of an alteration, amendment and/or cancellation, the Promoter will not compensate any individual for any reason whatsoever.
- 8.13. Each Participant and Guest indemnifies and holds harmless the Promoter, its associated companies, and the directors, officers, employees and agents of the Promoter and its associated companies, against any and all claims for any loss or damages, whether direct, indirect, consequential or otherwise, arising from any cause whatsoever connected to or arising out of his/her participation in any way in this Competition or his/her receipt, participation, ownership and/or use of a Prize. This indemnity is not intended to exclude any liability for any person which cannot be excluded under the Consumer Protection Act 68 of 2008.
- 8.14. The Promoter shall not be responsible for any lost, damaged, corrupted, delayed, incorrect or incomplete entries for any reason whatsoever. Proof of sending an entry will not be accepted as proof of receipt of such entry. The Promoter shall not be responsible for the failure of any technical element relating to this Competition that may result in an entry not being successfully submitted. The Promoter is not responsible for lost, damaged or delayed entries as a result of any network, computer or cell phone hardware or software failure of any kind. No entry from an agent, third party, organized group or entry automatically generated by computer will be valid or accepted. An entry will only be valid and accepted if it complies with all entry instructions and requirements. Any form of network or systems manipulation, including but not limited to Botnets, Sim Farms, Trojans, SMS malware may not be used when entering the Competition.
- 8.15. By participating in the Competition or receiving a Prize, each Participant and Guest gives the Promoter consent to: (i) market its products and campaigns to the Participant; (ii) conduct market research using personal information of the Participant and Guest which may be shared with third parties to enable the Promoter to develop appropriate marketing strategies in respect of its customers; and (iii) use the personal information and other details provided by the Participant during the Competition entry process for the purposes of facilitation of the Competition. A Participant and Guest may decline to provide or retract his/her consent by opting out via the opt out mechanism provided on the communications of the Promoter.
