
STELLA ARTOIS THE FESTIVE GET TOGETHER DINNER COMPETITION RULES

23 NOVEMBER 2023 - 8 DECEMBER 2023

1. INTRODUCTION

- 1.1 This promotional competition (“**Competition**”) is run by The South African Breweries (Pty) Ltd (“**Promoter**”) and is open to all persons of 18 years or older and resident in South Africa, except for: (a) the directors, members, partners, agents, consultants or employees of the Promoter and their immediate families; (b) the directors, members, partners, agents, consultants or employees of any suppliers of any goods or services to the Promoter in respect of this Competition; (c) directors, members, partners, agents, consultants or employees of the Promoter’s advertising and promotion agencies or associated companies; and (d) participating outlet owners and staff.
- 1.2 The rules set out in this document constitute the rules which will govern the Competition (“**Competition Rules**”).
- 1.3 Participation in the Competition by an entrant (a “**Participant**”) constitutes acceptance of these Competition Rules by that Participant.

2. COMPETITION PERIOD

This Competition will run from 23 November 2023 until 8 December 2023, both dates inclusive, or until the Promoter provides a public notice that the Competition has ended, whichever is earlier (“**Competition Period**”). Entries will only be accepted during the Competition Period.

3. COMPETITION ENTRY PROCESS

- 3.1 This Competition will take place on the Promoter’s official Stella Artois Facebook page (available at @stellaartoisafrika), X page (available at @stellaartoisza), and Instagram page (available at @stellaartoisafrika) (each a “**Promoter’s Page**” and collectively the “**Promoter’s Pages**”). A valid social media account and internet access is required to enter the Competition. Participants can enter the Competition through any one of the Promoter’s Pages.

- 3.2 The Promoter will run three episodes of a festive television show titled “The Festive Get Together” (“**The Festive Get Together Show**”) on the Mzansi Magic channel (channel 161 on DStv Compact) on or about the following times and dates: (a) first episode on 23 November 2023 at 21h00; (b) second episode on 30 November 2023 at 21h00; and (c) third episode on 7 December 2023 at 21h00. To enter the Competition, a Participant must do the following:
- 3.2.1 take a picture of themselves watching The Festive Get Together Show while enjoying a Stella Artois drink in a Stella Artois branded bottle, can or chalice with the branding “Stella Artois” clearly visible in the picture;
- 3.2.2 on any one of the Promoter’s Pages, post the above-mentioned picture on their timeline and/or stories; and
- 3.2.3 tag the relevant Promoter’s Page and include the hashtag #FestiveGetTogether.
- 3.3 Entry is only valid through this medium and in this manner. A Participant may enter the Competition a maximum of three times (once per episode of The Festive Get Together Show).
- 3.4 Participants who successfully complete the entry steps mentioned in Competition Rule 3.2 will be deemed to have entered the Competition and will stand a chance to win the Prize (as defined in Competition Rule 4).
- 3.5 Each Participant, in their engagement with this Competition pursuant to Competition Rule 3.2, shall ensure that everyone in their picture is of 18 years of age or older and each Participant shall ensure not to post a picture that is of an immoral, scandalous or illegal nature likely to have an adverse effect on the reputation of the Promoter, including but not limited to, a picture containing or depicting the underage drinking of minors, drinking while pregnant, abusive or sexual behaviour, and/or the participation in dangerous activities. Each Participant hereby indemnifies the Promoter, its associated companies, and the directors, officers, employees and agents of the Promoter and of its associated companies, against any and all losses, whether direct, indirect, consequential or otherwise, arising out of a Participant’s non-compliance with or breach of this Competition Rule 3.4 and/or any other content restrictions in these Competition Rules.
- 3.6 Participants are liable for their own data and voice charges in respect of the Competition participation as well as any verification process, if applicable.

4. DESCRIPTION OF THE PRIZE

- 4.1 The prize for this Competition is an exclusive Stella Artois dinner experience (the “**Dinner Experience**”) scheduled to take place in December 2023 at a Stella Artois spiritual home in Gauteng, at a time, venue and day to be notified and confirmed by the Promoter or its nominated agent, subject to Competition Rule 4.6 (the “**Prize**”). The details of what the Prize comprises is subject to the Promoter’s confirmation and may change at any time during or after the Competition Period with notice to the winner. The Prize currently includes: (a) starters, a main course meal and dessert for the winner and his/her Additional Attendees (as defined in Competition Rule 4.3); (b) seating at a Stella Artois themed table during the Dinner Experience which includes styling, napkins, welcome notes, an ice bucket, Stella Artois olive oil sets and chalices; and (c) complimentary drinks (i.e., water, Stella Artois drinks, and/or coffee) for the winner and each Additional Attendee as determined by the Promoter. Any beverage or food item which the winner and/or his Additional Attendees’ order at the Dinner Experience and which is not included as part of the Prize, will be at the winner’s and/or his/her Additional Attendee’s own expense. Neither the winner nor his/her Additional Attendees will be permitted to take home with them any item mentioned in (a) to (c) above, including any leftover food and/or drinks received at the Dinner Experience.
- 4.2 There is one Prize available to be won for this Competition and the Prize has a value of approximately R8,445.00.
- 4.3 The winner will be permitted to bring five guests to attend the Dinner Experience (each an “**Additional Attendee**” and together, the “**Additional Attendees**”). In order to receive the Prize, the winner shall (and shall ensure that each Additional Attendee shall) sign and submit an indemnity form to the Promoter, which will be provided by the Promoter.
- 4.4 The winner and his/her Additional Attendees are responsible for making their own arrangements to enjoy the Prize, including the cost of travel to and from the Dinner Experience, and any other costs (including but not limited to, accommodation costs) which are not communicated as forming part of the Prize by the Promoter.
- 4.5 The winner may not transfer the Prize, in whole or in part, to any other person or exchange the Prize for an alternate prize or for its cash value. The winner may not substitute him/herself with any other person.

- 4.6 The Promoter or its nominated agent will contact the winner via phone call and/or via direct message on the relevant Promoter's Page that the winner used to enter this Competition, to make arrangements for the winner to receive his/her Prize (including confirmation of the winner's and his/her Additional Attendees' availability to attend the Dinner Event).

5. WINNER SELECTION AND NOTIFICATION

- 5.1 The winner will be selected by a random draw process. The draw will take place on or about 8 December 2023 and will consist of all valid entries received during the Competition Period.
- 5.2 The winner will be notified by the Promoter on or about 11 December 2023 via direct message on the relevant Promoter's Page that the winner used to enter this Competition. If the Promoter is unable to contact the winner, he/she will be disqualified and a substitute winner may at the discretion of the Promoter be selected, using the same winner selection process.

6. WINNER VERIFICATION

- 6.1 A Participant and the winner's Additional Attendees must be over the age of 18 years old and must comply with the Participant eligibility criteria set out in Competition Rule 1.1 and the requirements in these Competition Rules, which may be verified by or on behalf of the Promoter. A Participant may be asked to provide a copy of his/her and/or a copy of his/her Additional Attendees' (as applicable) legal and valid identity document/passport/driver's license/proof of residential address/proof of purchase, if applicable, in order to be eligible to receive the Prize. The Promoter reserves the right to conduct the validation and verification process via automated means and/or any other means that the Promoter may deem necessary, and by participating in the Competition, all Participants consent to the appropriate validation and verification measures that the Promoter may implement from time to time.
- 6.2 The Prize will only be awarded by the Promoter and the Participant will only be regarded as the winner after the verification process set out in these Competition Rules has been completed to the satisfaction of the Promoter. Failing successful verification of the Participant, a substitute winner may be selected at the discretion of the Promoter.
- 6.3 The Promoter reserves the right to carry out audits in respect of the Participant to verify his/her eligibility and/or the validity of the Participant's entry. After a Participant has been informed of certain Competition requirements by the Promoter or an individual, including

(without limitation) those set out in Competition Rule 1.1 (a)-(d), the Promoter may disqualify the Participant if any fraud or cheating or related activity is suspected, including without limitation, through the manipulation of an entry or otherwise falsifying data. Should the Promoter or its agent determine that an entry or Participant is invalid or ineligible, the relevant Participant shall not be entitled to receive the Prize and will not be compensated in any way.

7. PRIZE FORFEITURE

7.1 The winner must communicate his/her and his/her Additional Attendees' full details to the Promoter or its agent as requested by the Promoter or its agent. Failure to do so may result in forfeiture of the Prize.

7.2 If the winner is unable to attend, receive or utilise (as applicable) the Prize, then the entire Prize shall be forfeited. There will be no compensation, in any form, including, but not limited to monetary compensation and/or rescheduling, to any party, irrespective of the reason/s for the inability of that winner to attend, receive or utilise (as applicable) the Prize.

7.3 Time permitting and subject to the Promoter's approval, where the Prize is forfeited a substitute winner may be chosen in the same manner as the original winner was chosen.

8. GENERAL

8.1 Should the process for entry into the Competition or the Prize involve any alcoholic beverage, all Participants shall ensure that it is enjoyed responsibly.

8.2 To the extent that any intellectual property right/s arise as a result of or through the creation and/or submission by a Participant of content, including without limitation any pictures, videos, drawings or other creative works, to enter this Competition, such intellectual property right/s will vest in the Promoter and the Participant hereby waives any associated right/s. To the extent such rights have vested in a Participant, the Participant hereby cedes, assigns and transfers (by way of present and future cession, assignment and transfer) to Promoter such rights and undertakes to do such things, takes such steps and sign such documents as are necessary to give effect to such cession, assignment and transfer. Each Participant indemnifies and holds harmless the Promoter from and against any and all claims, actions, legal proceedings, losses, damages and expenses (including attorney's fees and expenses) arising

as a result of or in connection with any actual or alleged infringement of any intellectual property rights of a third party arising from entry in the Competition and/or the Promoter's use of any content, including without limitation any pictures, videos, drawings or other creative works, created pursuant to the Participant's entry in the Competition.

8.3 In the event of a dispute, the Promoter's decision is final and binding and no correspondence will be entered into.

8.4 The timelines stated by the Promoter or its agent must be adhered to. Failing adherence to any timeline, at any stage, may result in disqualification and forfeiture of the Prize in its entirety with no compensation to any party by the Promoter.

8.5 Each Participant, by participating in the Competition, acknowledges, agrees and expressly consents to (and shall ensure that his/her Additional Attendees (as applicable) consent to):

8.5.1 the Promoter processing the Participant's and/or Additional Attendees' (as applicable) personal information, including in the form of names, telephone numbers, identity numbers and/or email addresses, during and after the course and scope of the Competition; and

8.5.2 the Promoter transferring the winning Participant's and his/her Additional Attendees' (as applicable) personal information, including names, telephone numbers, identity numbers and/or email addresses, to the relevant third parties in order to make any required travel, delivery or other arrangements, as may be applicable, during the course and scope of the Competition for utilisation of the Prize,

which processing and transfer shall take place in accordance with the provisions of the Protection of Personal Information Act 14 of 2013 ("**POPIA**") and any other applicable law, and for the purpose of giving effect to the Competition.

8.6 With the exception of Competition Rule 8.5 above, the Promoter will not share any personal information with any third party except where such disclosure is necessary to enable the Promoter to provide, deliver or in any other way give effect to these Competition Rules and/or the Prize, where such disclosure is permitted by law and/or where consent to sharing personal information is obtained from the relevant Participant by the Promoter. The Promoter will comply with the relevant data protection legislation, including POPIA.

- 8.7 A Participant and/or the winner's Additional Attendees may submit a request at <https://www.sab.co.za/content/data-subject-request-0> for the Promoter to:
- 8.7.1 correct or delete personal information about the Participant and/or an Additional Attendee (as applicable) in the Promoter's possession or under its control that is inaccurate, irrelevant, excessive, out of date, incomplete, misleading or obtained unlawfully; or
 - 8.7.2 destroy or delete a record of personal information about the Participant and/or an Additional Attendee (as applicable) that the Promoter is no longer authorised to retain.
- 8.8 The Promoter may make media announcements containing, or otherwise publish, the names and/or photographs of the winner and/or his/her Additional Attendees without remuneration being payable to the winner or an Additional Attendee, provided that the Promoter will not do so if the winner or an Additional Attendee communicates in writing to the Promoter that he/she does not want his or her names or photographs to be contained in media announcements or otherwise published. The winner shall ensure that his/her Additional Attendees consents to the provisions of this Competition Rule 8.8.
- 8.9 Should the Prize not be available despite the Promoter's reasonable endeavours to procure the Prize, the Promoter reserves the right to substitute the Prize with another of equal value as determined in the Promoter's sole discretion and subject to availability. No person will be entitled to be compensated in any way in this instance by the Promoter.
- 8.10 The Promoter will not be responsible for any costs, expenses or other liabilities incurred by the winner and/or an Additional Attendee which are not expressly contemplated as part of the Prize.
- 8.11 These Competition Rules may be amended by the Promoter on public notice at any time during the Competition Period or thereafter. These Competition Rules will be interpreted by the Promoter only.
- 8.12 The Promoter reserves the right to alter, amend or cancel this Competition in whole or in part. Any alterations, amendments or cancelations will be interpreted by the Promoter only. In the

event of an alteration, amendment and/or cancellation, the Promoter will not compensate any individual for any reason whatsoever.

- 8.13 **Each Participant indemnifies and holds harmless the Promoter, its associated companies, and the directors, officers, employees and agents of the Promoter and of its associated companies, against any and all claims for any loss or damages, whether direct, indirect, consequential or otherwise, arising from any cause whatsoever connected to or arising out of his/her participation in any way in this Competition or his/her (and/or his/her Additional Attendees' (as applicable)) receipt, participation, ownership and/or use of the Prize. This indemnity is not intended to exclude any liability for any person which cannot be excluded under the Consumer Protection Act 68 of 2008.**
- 8.14 The winner shall procure the compliance by his/her Additional Attendees of these Competition Rules in relation to the receipt, use and/or redemption, and/or benefitting by an Additional Attendee from, a Prize, and hereby indemnifies the Promoter, its associated companies, and the directors, officers, employees and agents of the Promoter and of its associated companies, against any and all losses, whether direct, indirect, consequential or otherwise, arising out of a claim or threatened claim by an Additional Attendee in relation to this Competition.
- 8.15 The Promoter shall not be responsible for any lost, damaged, corrupted, delayed, incorrect or incomplete entries for any reason whatsoever. Proof of sending an entry will not be accepted as proof of receipt of such entry. The Promoter shall not be responsible for the failure of any technical element relating to this Competition that may result in an entry not being successfully submitted. The Promoter is not responsible for lost, damaged or delayed entries as a result of any network, computer or cell phone hardware or software failure of any kind. No entry from an agent, third party, organized group or entry automatically generated by computer will be valid or accepted. An entry will only be valid and accepted if it complies with all entry instructions and requirements. Any form of network or systems manipulation, including but not limited to Botnets, Sim Farms, Trojans, SMS malware may not be used when entering the Competition.
- 8.16 By participating in the Competition, each Participant gives the Promoter consent to: (i) market its products and campaigns to the Participant; (ii) conduct market research using personal

information of the Participant which may be shared with third parties to enable the Promoter to develop appropriate marketing strategies in respect of its customers; and (iii) use the personal information and other details provided by the Participant during the Competition entry process for the purposes of facilitation of the Competition. A Participant may decline to provide or retract his/her consent by opting out via the opt out mechanism provided on the communications of the Promoter.
